## **Clarification Meeting**

Clarification Meeting for potential tenderers was held on July 4th, 2014 and commenced at 10:00 A.M.

Project manager assistant Nemanja Đukić was informed the participants of the tender that the main purpose of this meeting was explaining tenderers all unclear details and issues related to the project as well as answering their questions. He informed tenderers that deadline for requesting any additional information from the Contracting Authority is 08.07.2014. at 3:30 P.M. Mr. Đukić also asked for the delivery of all the questions in writing to avoid misinterpretation or omission of questions during the preparation of the Minutes. He pointed out that the language of tender procedure is English, and that all written communication for this tender procedure and contract must be in English. He explained that the public procurement is conducted by special procedure which is proscribed by the European Union and Practical guide to Contract Procedures for EU External Actions (PRAG). He also emphasized the importance of strictly adhering to the rules described in PRAG, for public procurement to be successful, as well as the entire project.

Financial assistant Stanislav Vujčić explain conditions and required capacities for tenderers. He also
